AGREEMENT

This agreement is made on this 11th day of April, 2017 at Bhubaneswar:

Between

Hi-Tech Medical College and Hospital, At- Pandara, Rasulgarh, Bhubaneswar, PIN- 751025, represented by its Director, Mr. Suresh Kumar Panigrahi, here in after called the **First Party**.

And

AMBROSMART Pvt. Limited, having its registered office at Athalira, PS- Astaranga, Dt- Puri, Pin- 752109 and operating from its office at Rasulgarh, Bhubaneswar, Dt- Khordha, represented by its Managing Director Mr. Ashis Kumar Mohanty, here in after called the **Second Party**.

Preamble:

Whereas, the first party runs a medical college and hospital in the name of "Hi-tech Medical College and Hospital" at Bhubaneswar.

Whereas, the second party is engaged in advertisement activity of health care sector through its privilege card in the state of Odisha,

Suresh Kumar Panigrahi

Ashis Kumar Mohanty

Whereas, the second party has shown interest to tie-up with First Party and advertise the latter through its Co-branded privilege card,

Whereas, the First Party in return has offered to give discount on hospital charges to the privilege card holders of the second party .

The agreement witnesses the following:

1. The second party will advertise the first party in its privilege card.
2. The privilege card of the second party will be a co-branded card which will contain the logo and name of both the parties apart from other information.
3. The first party will provide discount to the privilege card holders of the second party on its various hospital service charges.
4. The second party shall not be responsible for any unforeseen happenings that may happen to any card holders during their treatment in the first party hospital.
5. The second party will not enter in to such type of tie-ups with any hospital situated in the twin city of Bhubaneswar and Cuttack and Rourkela.
6. The second party will have the sole discretion to finalise fees for its privilege card.
7. The first party will not bear any expenses incurred by the second party either for preparation of the co-branded cards or for marketing of such cards.
8. The second party will provide at least 1000 patients to the first party during the 1st six months of signing of this agreement.
9. The first party will extend all type of facilities available in its hospital to the card holders against payment.
10. In case the management of the first party brings any changes in their hospital policy, the same will be applicable and acceptable to the second party as well as to the card holders.
11. This agreement will be valid for a period of 5 years from the date of its execution.
11. In case any of the party fails to fulfil its part, the other party is at liberty to terminate the contract. However, this agreement can be terminated by either party by giving 90 days prior notice.
