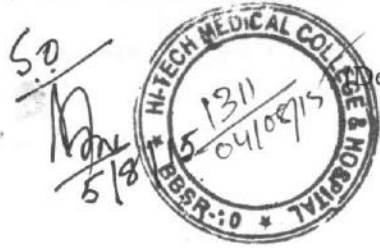

NOTIFICATION

S.O..... In exercise of the powers conferred by sub-section(2) of the section 11 of the Indian Medical Council Act, 1956 (102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act, namely:-

“Master of Chirurgie
(Urology/Genito-Urinary Surgery)”

M.Ch(Urology/Genito-Urinary Surgery)

(This shall be a recognised medical qualification when granted by West Bengal University of Health Sciences, Kolkata, West Bengal in respect of the students being trained at Nilratan Sircar Medical College, Kolkata, West Bengal on or after 2014)

“Master of Chirurgie(Neuro Surgery)”

M.Ch(Neuro Surgery)

(This shall be a recognised medical qualification when granted by West Bengal University of Health Sciences, Kolkata, West Bengal in respect of the students being trained at Nilratan Sircar Medical College, Kolkata, West Bengal on or after 2014)

“Master of Chirurgie
(Cardio Thoracic and Vascular Surgery)”

M.Ch(CTVS)

(This shall be a recognised medical qualification when granted by West Bengal University of Health Sciences, Kolkata, West Bengal in respect of the students being trained at Nilratan Sircar Medical College, Kolkata, West Bengal on or after 2014)

“Doctor of Medicine(Paediatrics)”

MD(Paediatrics)

(This shall be a recognised medical qualification when granted by West Bengal University of Health Sciences, Kolkata, West Bengal in respect of the students being trained at Chittaranjan Seva Sadan Hospital, Kolkata, West Bengal on or after 2014)


“Masters of Surgery(Obstetrics & Gynecology)”

MS(OBG)”

(This shall be a recognised medical qualification when granted by West Bengal University of Health Sciences, Kolkata, West Bengal in respect of the students being trained at Chittaranjan Seva Sadan Hospital, Kolkata, West Bengal on or after 2014)

- Note to all: 1.The recognition so granted to a Postgraduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
2. Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Postgraduate Course.
