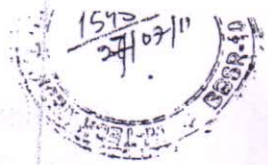

**Subject:- Fee Structure of Post Graduate Courses In Medical Programmes.**

No. I-TI-102/2011 9456 /I, In exercise of power conferred on Government under sub-section - 7 of section - 6 and other provisions of the Orissa Professional Educational Institutions (Regulation of Admission & Fixation of Fee) Act, 2007 and basing on the recommendation of the Fee Structure Committee constituted in terms of interim order of the Hon'ble Supreme Court dated 1<sup>st</sup> June, 2007 in Special Leave Petition (Civil) No.(s) 10318, 10319, 10329 and 10330 of 2007, the Government have been pleased to fix the fee structure of Post Graduate Courses in Medical Programmes in respect of the following institution as has been detailed below w.e.f. academic session 2011-12.

(A) The fee structure of Post Graduate Courses in Hi-Tech Medical College and Hospital, Bhubaneswar in respect of Anatomy, Physiology and Bio-Chemistry subjects for General and Management Quota Seats.

No. 9457 /I, The Fee Structure of Hi-Tech Medical College and Hospital, Bhubaneswar for Post Graduate Courses in Anatomy, Physiology and Bio-Chemistry in respect of General Seats is fixed at **Rs.4,50,000/-** per annum w.e.f. academic session 2011-12 along with an additional amount of Rs.15,000/- towards admission process until further orders.

No. 9458 /I, The Fee Structure of Hi-Tech Medical College and Hospital, Bhubaneswar for Post Graduate Courses in Anatomy, Physiology and Bio-Chemistry in respect of Management Quota Seats is fixed at **Rs.5,00,000/-** per annum w.e.f. academic session 2011-12. until further orders.

(B) Fixation of optional cost.

The optional cost and caution money in respect of Post Graduate Courses in Medical Programmes are fixed as follows w.e.f. academic session 2011-12.

Sl No.	Particulars	Optional Fee and Caution Money
01	Hostel Cost for all courses	(i) Rs. 18,000.00 per year per student -Own hostel (ii)Rs. 10,000.00 per year per student - Rented hostel
02	Transportation Cost	Rs. 8,000.00 up to 20km and Rs. 12,000.00 for more than that for the full year
03	Pre-Placement Training	Rs. 8,000.00 for total course subject to maximum of Rs. 4,000.00 per year.
04	Uniform & Blazer	The cost of uniform provided by the Colleges shall not exceed Rs.1,500.00 and for Blazer and Uniform together provided by the College shall not exceed Rs.4,000.00.
05	Caution Money (One time refundable)	Rs. 2,500.00

The fee structures as have been fixed above are to be followed in letter and spirit and Institution/College is not allowed to charge any other fee in any name other than the prescribed above.

If any institution will collect any other fee in any name in guise, the same will be seriously viewed and may consider to withdraw NOC and move MCI for withdrawal of approval in favour of the defaulting institution/College. Government will also impose penalties on the defaulting institution /College as per the provisions of aforesaid Act, 2007 if any institution charges any other amount in any form other than the prescribed fee structure.

Any clarification on the fee structure, if so necessary, the decision of the Government in Industries Department is final and binding.
